



SOUTH CAROLINA REALTORS® REALTOR® OF THE YEAR PROGRAM

The REALTOR® of the Year program has been designed to honor and recognize those REALTOR® members who have contributed most to the advancement of the real estate profession and the community. A member Board or Association REALTOR® of the Year should be selected each year. These REALTORS® will be recognized at the Leadership Conference in January and may be submitted as candidates by the local Board/Association for selection as the State REALTOR® of the Year, announced at the Annual Convention.

State REALTORS® of the Year are recognized by NAR at the Annual Awards Luncheon during the NAR Convention in November. NAR does not select a National REALTOR® of the Year, but recognizes the State REALTORS® of the Year equally.

PURPOSE:

- To recognize and award REALTOR® members for effort and work expanded in the interest of fellow REALTORS®, the real estate profession, and the community.
- To demonstrate to the public outstanding examples of the work done by REALTORS®.
- To point out the qualifications of those REALTORS® best suited for consideration of leadership positions in organized real estate.
- To foster a spirit of competition among those who are in a position to serve the objectives and needs of the local Board/Association, SCR and NAR.

SUGGESTED GUIDELINES FOR NOMINATION:

- **Member (Local) Board/Association Activities** – Board or Association officer, director and/or committee chair or member, special projects, seminar and meeting participation.
- **S.C.R. Activities** – officer, director, committee chair or member, attendance at NAR conventions and meetings, educational designation achievements.
- **NAR Activities** – officer, director, and/or Societies, attendance at NAR conventions and meetings, educational designation achievements.
- **Community Activities** – local, state or national level participation in civic and service clubs, charitable organizations, legislative and political interests, fraternal and/or religious affiliations.

Other Contributing Factors:

- **REALTOR® Spirit** – high principles, faithfulness to laws and regulations of the Code of Ethics and local Board/Association, and furtherance of principles of good real estate practice among other brokers and the general public.
- **Business Accomplishments** – recognized for professional business conduct, service to clients, imaginative and creative advertising programs, rehabilitation work, and land utilization.
- **Political Involvement** – recognized for support of RPAC, local, state and national political involvement and involvement with the REALTOR® Party.
